HORSE TRAINING CONTRACT

Horse Training Contract

This Agreement is made between *Jeff Strahle, Show-Me Trail Ride Outfitter* (Trainer) and _____ (Owner), owner of the horse described herein.

Fee

In consideration of \$_____.____ per month paid by Owner in advance on the first day of each month, Trainer agrees to board and train said horse beginning _____^(date), on a month-to-month basis. Included in the fee above is hay, grain, training time (no less than 2 hours per day), and pasture turn-out.

Owners Responsibilities:

- (a) A current Coggins is mandatory before bringing the horse to Trainer's property
- (b) Grain and hay will be available for your horse; if specialized feeds or supplements are needed, they must be supplied by Owner.
- (c) Please bring along your horses headstall, bit, and saddle pad.
- (d) Fill out two copies of this contract in full and sign both copies.

Trainer Responsibilities:

(a) Trainer agrees to provide normal and reasonable care to maintain the health and well-being of said horse. Trainer shall furnish all labor, provide suitable facilities and care for horse in an adequate manner with feed being determined by the Trainer. Care and services NOT included in the fee are: Farrier services, de-worming, vaccinations, fly-repellant.

(b) The Trainer shall train horse and perform all services in accordance with generally accepted professional standards. Trainer cannot and does not guarantee the effect of the training program or that any particular results will be achieved, since this depends a great deal on the individual physical and mental ability of each horse. The Trainer has complete control over the manner of training and shall take all precautions for the proper performance thereof.

Right to Refuse Services:

Trainer reserves the right to refuse the continuation of training services of any horses for any reason, to include but not limited to: animal's poor health or unsoundness, dangerous propensities, habits and/or vices, and/or non-trainable condition which Trainer may not be equipped or capable to handle; Owner's refusal to obey stable rules or to cooperate with Trainer on reasonable requests relative to the management, training, welfare and safety of animals and people on premises; and, also in such event Trainer shall give Owner seven (7) days written notice to remove horses from premises.

Emergency Care:

If emergency treatment is needed, Trainer will attempt to contact Owner but, in the event Owner is not reached, Trainer has the authority to secure emergency veterinary and/or farrier care. Owner is responsible to pay all costs relating to this care. Trainer is authorized as Owner's agent to arrange billing to Owner.

Risk of Loss:

While the horse is boarded with Trainer, Trainer shall not be liable for any injury, sickness, death or theft suffered by the horse of any other cause of action arising from or connecting to the boarding of the horse. Owner fully understands that Trainer does not carry any insurance for any horses not owned by him for boarding or for any other purposes, for which the horses are covered under any public liability, accidental injury, theft, or equine mortality insurance; all risks are assumed by Owner. Owner agrees to hold Trainer harmless from any loss or injury to said horse. All costs, no matter how catastrophic, connected with boarding, training, or for any other reason for which the horse in on the premises of Trainer, are to be borne by Owner.

Hold Harmless:

Owner agrees to hold Trainer harmless from any claim resulting from damage or injury caused by said horse and agrees to pay legal fees incurred by Trainer in defense of a claim resulting from damage by said horse.

Right of Lien:

Trainer has the right of lien as set forth in the law of the State of Missouri (Chapter 430.150) for the amount due for the board and training and shall have the right, without process of law, to retain said horse until the indebtedness is satisfactorily paid in full.

Termination:

Either party may terminate this Agreement given thirty (30) days notice to the other. In the event of a default, the wronged party has the right to recover reasonable attorneys' fees and court costs resulting from this failure of either party to meet a material term of this Agreement.
