HORSE TRAINING WAIVER

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of the provision of horse training services and/or horseback riding lessons offered by *Jeff Strahle, Show-Me Trail Ride Outfitter*, I, the undersigned, do hereby voluntarily enter into this release and waiver of liability and indemnity agreement. By signing this document, I hereby acknowledge and agree as follows:

1. I understand that horseback riding and/or the handling of horses and ponies are inherently dangerous activities that can result in injury and/or death.
2. I wish to participate in horse training and/or horseback riding lessons under the instruction of *Jeff Strahle, Show-Me Trail Ride Outfitter*, with full assumption of the risks involved.
3. I will conduct myself in a manner such as to prevent injuries to myself and others, and agree to follow the instruction of *Jeff Strahle, Show-Me Trail Ride Outfitter*.
4. I understand that *Jeff Strahle, Show-Me Trail Ride Outfitter* does not control the actions of the horse(s) I will be riding.
5. In the event that I have entrusted my own horse to *Jeff Strahle, Show-Me Trail Ride Outfitter* for training, or am riding my own horse under the instruction of *Jeff Strahle, Show-Me Trail Ride Outfitter*, I acknowledge that my horse may be subject to injury or death from interaction with other animals, diseases or self-inflicted injury. I understand and acknowledge that I am responsible for providing my own insurance to cover loss or damage sustained or caused by my horse including, but not limited to theft, illness, property damage, bodily injury and/or death.
6. **On behalf of myself, my successors, heirs and assigns, I do hereby release, discharge, indemnify and hold harmless *Jeff Strahle, Show-Me Trail Ride Outfitter* and his/its agents and/or employees from any and all claims, demands, suits, costs and charges in connection with or arising out of the provision of horse training services and/or horseback riding lessons offered by *Jeff Strahle, Show-Me Trail Ride Outfitter*, including but not limited to property damage, bodily injury and/or death, except only for loss, harm or injury caused by gross negligence or willful misconduct.**
